


# -Vision of उन्नत भारत

#### **Present Status**

 District Planning Committees [DPC] not adequately equipped to lead the process of district planning ........ at best, perform as committees that meet occasionally to hurriedly endorse, without adequate appreciation, a 'plan' or plans prepared by departmental officials. [PIg Com 2006]

- Capability-building of the officials of the District Planning Committee
- Capability-building of Panchāyat members and officials
  - Creating awareness of new technologies for sustainable development

# Box 9: Professional support for District Planning Committees through Technical Support Institutions, persons or groups

A District Planning Committee should have the flexibility to hire the services of technical support institutions, resource persons or groups to help it facilitate the envisioning and bottom-up planning process in local governments. The role and responsibilities of the Technical Support Institutions (TSIs) should be determined by the District Planning Committee and monitored by the local government concerned.

Similar support can be secured by local governments, either independently, or from an empanelled list made available by the District Planning Committee.

Separate TSG/Institutions comprising sectoral experts can be constituted at the Intermediate Panchayat level to provide guidance to elected representatives as well as to other groups that assist Village Panchayats and municipalities.

The District Planning Committee TSG should coordinate with TSGs of local bodies for smooth facilitation of planning at various levels and also for integration of plans from different levels.

The District Planning Committee TSG should provide regular feedback on progress of planning process and also implementation of the plan, once approved by the District Planning Committee.

  - to provide 24x7 uninterrupted power supply to all homes. A sum of Rs. 500 crores has been set aside for this scheme.
- Shyama Prasad Mukherji Rurban Mission
  - to deliver integrated project based infrastructure in the rural areas. ...300 clusters .... 5142 crores ...
- Soil Health Card Scheme for Every Farmer
- सांसद आदर्श ग्राम योजना
  - Resources through convergence of government schemes
- Pradhan Mantri Krishi Sinchayee Yojana
  - to meet the need to provide assured irrigation to the farmer.
    A sum of Rs.1,000 crores is being set aside for this scheme.
- A Dedicated TV Channel 'Kisan TV' for Farmers

### Shyama Prasad Mukherji Rurban Mission

- Skill development training linked to economic activities,
- Agro Processing/Agri Services/Storage and Warehousing, Digital Literacy,
- Sanitation,
- Provision of piped water supply,
- Solid and liquid waste management,
- Village streets and drains,
- Street lights,
- Fully equipped mobile health unit,
- Upgrading school /higher education facilities,
- Inter-village road connectivity,
- Citizen Service Centres- for electronic delivery of citizen centric services/e-gram connectivity,
- Public transport.,
- LPG gas connections.

- Provide technical inputs on various aspects of SM Rurban mission

#### Role of Technical Institutions

- To monitor and provide feedback to the district administration on the progress of the plan implementation
- Identifying missing gaps in technology which could be converted into R &D projects.
- Involving students in UBA through these projects of direct relevance to rural India.
- Coordinating Institution { IIT Delhi } to organize training programmes for all stakeholders.
- Considering that there are 589 ZPs and 6325 PSs spread over the country, how to organize this technical support?

#### Action Plan

A. Capability building of Local government officials and implementing agencies including NGOs and Tls involved in part B; participation in DPCs help integrate the plans received from various levels

**National Level Institutions** [ 200 ]

B. Participate in Panchāyat Samitis during planning process, provide feedback to the district administration on the progress of the plan implementation, Identifying technical problems which could be converted into R&D projects.

State Level Institutions: Engg and Agricultural Colleges, Management institutes, community polytechnics [ 1000]
